4.01 Airline Lease Agreement with Frontier Airlines

**MOTION by Tim George, SECOND by Jeff Munger, to approve and recommend to the Board of Finance and City Council the authorization to enter into a non-signatory airline lease agreement with Frontier Airlines, Inc.**

**DISCUSSION:**

- **The non-signatory lease agreement was explained. With the agreement the airline pays more, but there is less risk. The airline along with airport legal counsel developed the agreement. It is customary for low cost carriers to take on no risk.**

- **Frontier Airlines will have Gate 12 (new gate and ticket counter) between Delta and American Airlines.**
